

He has a repertoire as a trainer and public speaker on a variety of legal topics who is regularly invited to speak at events, be a panellist or a moot judge at student-held events.

In his 20 years as a past practising advocate and solicitor in Singapore, M. Ravi was at the forefront of several landmark human rights and constitutional law cases before the Supreme Court. The cases involved the following issues:

Andrew Harding is Visiting Research Professor of Law at the Centre for Asian Legal Studies. National University of Singapore (NUS). He is recognised as a leading scholar in comparative constitutional law with special reference to South East Asia, Asian legal traditions, and law and development. At NUS, he has been Director of the Centre for Asian Legal Studies, Director of the Asian Law Institute, and Chief Editor of the Asian Journal of Comparative Law.



Professor Harding has made extensive contributions to scholarship having published 22 books as an author or editor. He is co-foundingeditor of Hart Publishing's book series 'Constitutional Systems of the World', a major resource for contextual analysis of constitutional systems, and has authored books on Thailand and Malaysia in that series. Just to name a few, his recent books and contributions include:

- Constitutionalism and Legal Change in Myanmar (2017);
- Constitutional Courts in Asia: A Comparative Study (2018);
- Thai Legal History (2021); and
- Constitutionalism and Development: A Mismatch or a Dream Team" in the Law and Development Review (2019)

His 2019 article mentioned above on the sustainable development goals received wide attention. Professor Harding has also been invited to provide expert legal opinions and was recently deposed as an expert witness on Myanmar law in the case of *Jane Doe v Meta Platforms* in the District Court, Oakland, California, 9 June 2022.

Professor Harding's work with M. Ravi Law will span across Myanmar, Thailand, Malaysia and Singapore. When not doing any of the above, Professor Harding has taken a keen liking to writing & publishing novels.

Kyaw MIn San is the author of "Critical Issues for the Rule of Law in Myanmar" and he has written several papers on human rights issues.

She is also the executive coordinator of the Community Resource Centre (CRC), an NGO based in Thailand.

She is also the coordinator of the Mekong Legal Network (MLN).

Sor Rattanamanee and her team worked to secure justice for 700 Cambodian families who were forcibly displaced due to a Thai sugar company by a class action lawsuit that 2 representatives of the 700 families filed. In this case, she sought justice for the community to hold the company accountable for their human rights violations. Recently, the courts ruled that the representatives can sue the sugar company and the case should move forward. This lawsuit was the first of its kind in transboundary human rights law under class action lawsuit and the fight continues.

She also filed a case against a Thai state enterprise to stop the Power Purchase Agreement for Xayaburi Hydropower that threatened the people and the environment in the Mekong River. The action was brought in the Thai Administrative court. This case became the first transboundary case where the Supreme Administrative Court granted leave to accept the case for consideration.

Sor travels extensively to participate and speak in global human rights conferences including to the United Nations. She is also the Thai National Representative to the South East Asian Public Interest Lawyers network.

Sor Rattanamanee graduated from the Faculty of Law at Thammasat University, Bangkok.
